BOROUGH OF FOLSOM

A RESOLUTION IMPOSING A TEMPORARY MORATORIUM ON THE ACCEPTANCE OF CANNABIS APPLICATIONS FOR LOCAL LETTERS OF SUPPORT FOR A PERIOD OF ONE (1) YEAR AND PROVIDING FOR ADDITIONAL TERMS

WHEREAS, on November 3, 2020, more than two-thirds of the registered voters in New Jersey voted to approve Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults 21 years of age and older; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act", N.J.S.A. 24:6I-31, et seq. (the "Act"), which legalized the recreational use of marijuana by adults 21 years of age or older; and

- WHEREAS, the Act establishes a comprehensive regulatory and licensing scheme for commercial, recreational (adult use) cannabis operations, and its use and possession; and
- **WHEREAS**, on July 13, 2021, the Council of the Borough of Folsom adopted Ordinance #09-2021 imposing development regulations on Classes 1 through Class 6 of licensed cannabis establishments; and
- **WHEREAS**, on September 13, 2022, the Council of the Borough of Folsom adopted Ordinance #10-2022 which amended the previous development regulations; and
- **WHEREAS**, on May 10, 2022, the Council of the Borough of Folsom adopted Ordinance #05-2022 which further amended Regulations, and
- WHEREAS, on March 11, 2025, the Council of the Borough of Folsom by way of Ordinance #4-2025 amended the previous regulations; and
- WHEREAS, the Borough desires to impose a temporary moratorium on the approval of all classes of cannabis licenses authorized in the Borough for a period of one (1) year effective upon the adoption of this Resolution, except that it may consider any applications received prior to the passage of this Resolution and may issue a local license to any entity which has previously received a letter of local support; and
- **WHEREAS**, since the passing of Ordinance 09-2021 the Borough has provided resolutions of support in aid of application to the Cannabis Regulatory Commission; and
- WHEREAS, it is in the best interests of the Borough to impose a temporary stay on further cannabis applications within the Borough to allow time to observe how the previously endorsed cannabis ventures operate within the Borough and the impacts on the Borough of cannabis businesses given the emerging nature of the cannabis industry within the State and the lack of experience in the Borough or elsewhere in the State of this new industry; and
- WHEREAS, during this application freeze, the Borough will not continue to accept applications and will not consider issuing resolutions of local support of any class for at least a period of twelve (12) months except that it may consider any applications received prior to the passage of this Resolution and may issue a local license to any entity which has previously received a letter of local support; and
- WHEREAS, it is also the intention of the Borough's Council to review the current cannabis ordinance and determine if any amendments are necessary or appropriate in the best interests of the Borough; and
- WHEREAS, previously endorsed applicants who require additional or amended endorsement from the Borough Council in connection with their application to the Cannabis Regulatory Commission may request any additional endorsement from the Borough for such review during this moratorium.

NOW, THEREFORE BE IT RESOLVED by the Council of the Borough of Folsom, County of Atlantic, State of New Jersey:

- 1. That the aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The Council of the Borough of Folsom will not consider any further applications for local support of any class of cannabis license for a period of no less than twelve (12) months so that the Borough may review the impact of those businesses which have already received a cannabis license and determine the best forward course of action for the Borough in this emerging industry, except that it may consider any applications received prior to the passage of this Resolution and may issue a local license to any entity which has previously received a letter of local support.
- 3. The Clerk of the Borough of Folsom will not continue to accept applications for local letters of support and proposed applicants shall be advised of this Resolution and moratorium.
- 4. Any applicant who has previously received an endorsement from this Council who requires additional or amended endorsement from the Borough Council in connection with their application to the Cannabis Regulatory Commission during this moratorium may request any additional endorsement from the Borough for such review during the moratorium.
- 5. This Resolution shall take effect immediately.

WHEREAS, furthermore, the public property was placed for public sale by the Borough of Folsom on May 6, 2021 with a minimum bid of \$1,000.00 for Block 2605 lot 707 and no bids were made on the real property.
