There was a roll call vote with ayes all with the exception of Councilman Smith's and Councilman Jantz's abstention.

APPROVAL OF THE EXECUTIVE MINUTES FROM April 13, 3016

A motion to approve the minutes was made by Councilwoman Veneziani and seconded by Councilman Arena.

There was a roll call vote (Mayor included) with ayes all with the exception of Councilman Smith, Jantz and Councilman Gummoe's abstention.

MEETING OPEN TO PUBLIC:

Councilman Arena is stepping down from dais to speak as a business owner and resident-(1002 Black Horse Pike) Trish Arena (1002 Black Horse Pike) speaking on behalf of Mrs. Arena, President of Bell Liquors, Inc. Mr. Arena was speaking here this evening because he wanted the Mayor and Council to know that he has filed a written objection against the transfer of Collings Lakes Food Market, Inc. to Rt. 322 Liquors. Mr. Arena stated that he felt there has been an injustice done to him by the Borough of Folsom and New Jersey ABC and the Planning/Zoning Board. Mr. Arena made reference to the handout he gave to Council before the meeting started. Mr. Arena stated that after researching all the OPRA material the reasons the Collings Lakes Food Market is in existence is false and that it is a bogus license Mr. Arena stated that his business has suffered economic distress over this. Mr. Arena stated he felt that this could have been stopped. Mr. Arena stated that the Planning Board came back to Council in 2014 and stated the Engineer and Attorney said conditions were to be put on this license. Those conditions are then sent to the ABC. If the ABC agrees with those conditions then everything is a go. Mr. Arena stated that he has looked at our resolutions and minutes to see if there was any discussion about these conditions and there is none except Council was told it was the end unit (D) and that is what you voted on. A long discussion ensued Mr. Arena stated he is trying to get this license expunged completely.

Keith Bonchi stated that this bar has one table with three bar stools with no real restaurant and seems to be a sham. Keith Bonchi asked Mayor and Council for permission to research this issue since this is the first time a transfer or renewal has come up with him as Solicitor and in anticipating this coming up he sent Solicitor Fran Ballak on his way home to go in and order a beer to see what it is like.

Council President Pagano asked Charlie Arena what you want from the Borough. Mr. Arena stated I'm putting the ball in your court right now as far as that expansion is concerned. Is is fair or not fair is it legal or not legal? Mr. Arena stated he will go to the ABC about that license because it should have never existed in the first place.

Donna Sutts (**15 E Park Avenue**) stated she was not able to attend the last planning/zoning board meeting and she was reassured that it would be just three bar stools. Donna stated she was told that they need a bigger package goods store. She was promised it was not going to get any bigger. Donna stated she sees the door opened during the day and sees banners on the fence. Donna asked the Mayor and Council to take a closer look at this issue.

Christine Esposito (9East Park Avenue) stated she lives behind the liquor store and voice her disproval of the expansion of Colling Lakes Food Market. Christine also stated she never received a notice of the Planning Board Meeting. She stated that she feels that she was lied to at last Planning Board meeting over this issue.

Mayor DeStefano asked Council if we agreed to have our Solicitor investigate this issue. All were in favor.

Council President Pagano suggested forming a Committee to handle this issue. Keith Bonchi stated not now let him research first.

ORDINANCE NO. 05-2016

AN ORDINANCE AMENDING ORDINANCE NO. 04-2016 WHICH ESTABLISHED A NEW CHAPTER FOR THE REGULATION OF ALARM SYSTEMS

NOW, THEREFORE, BE IT ORDAINED by the counsel of the Borough of Folsom, County of Atlantic, State of New Jersey as follows:

WHEREAS, pursuant to Ordinance 04-2016 Council for the Borough of Folsom passed an Ordinance establishing a New Chapter for the Regulation of Alarm Systems; and

WHEREAS, it has been determined necessary and appropriate to make certain amendments to Ordinance 04-2016; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED, by the council of the Borough of Folsom that the portion of Ordinance 04-2016 which was entitled "VIOLATIONS AND PENALTIES" is hereby amended so as to read as follows:

<u>VIOLATIONS AND PENALTIES</u>. Anyone who is convicted of violating this article in the Borough of Folsom Municipal Court is subject to the following penalties:

- A. First offense and second offense: a warning.
- B. Third offense: a fine of \$50.00 payable through the Violations Bureau in the Borough of Folsom.
- C. Fourth offense: A Fine of \$100.00 payable through the Violations Bureau in the Borough of Folsom.
- D. Fifth offense: A fine of \$200.00 payable through the Violations Bureau in the Borough of Folsom.

E. Sixth and Subsequent offenses: A fine of \$300.00 payable through the Violations Bureau in the Borough of Folsom. A Court appearance shall not be required unless noted by an officer in the performance of his duties.

AND BE IT FURTHER ORDAINED, that all Ordinances inconsistent herewith are hereby repealed to the extent they are inconsistent to the ordinance herewith and the balance shall remain in full force and effect.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced and passed on the first reading at a regular meeting of the Borough Council in the Borough of Folsom, County of Atlantic and State of New Jersey, held on May 11, 2016. ENGINEER'S REPORT:

2014 Community Development Block Grant Funding - ADA Access Project

The Atlantic County Improvement Authority (ACIA) has requested some additional documentation from our office to complete their review. The final documents will be forwarded by the end of the week. Once approved the Borough can expect the issuance of the reimbursement funds.

FY15 State Aid Project - 8th Street

Our office is continuing to hold ongoing discussions with the contractor, Arawak Paving, on how they plan to resolve the transition from the bridge to the roadway at the beginning of the project. At this time they are continuing to be non-responsive. Final payment will not be recommended until the work is completed as per the design plans.

FY16 State Aid Project - 14th Street

As noted last month, the Borough received formal acknowledgment of the funding for the Resurfacing of 14th Street in the amount of \$190,000.00. The resolution authorizing our office to begin with the design services for the project is on tonight's agenda. We anticipate having the project completed during the fall 2016.

2016 Community Development Block Grant Funding

As authorized by the Mayor and Council we have submitted the application for the funding from the Atlantic County Improvement Authority. The Borough should receive a response by the end of the calendar year.

Miscellaneous ADA Improvements

Our office has prepared a proposal to complete the design and construction management services for the construction of several ADA compliant projects to utilize the remaining funds from previous years Community Development Block Grants. As noted in the correspondence by the ACIA, the funds are in danger of being deobligated if not spent by June 30, 2016. The resolution authorizing our office to begin with the design services for the project is on tonight's agenda.

There are three potential projects that have been discussed:

Construction of a compliant ADA walking pathway and parking around Penny Pot Park

Installation of ADA automated door operators at Borough Hall.

Construction of senior exercise equipment and ADA compliant parking stalls at the Falcon's Crest Field.

NJDOT Route 54 / 322

We contacted the NJDOT Resident Engineer for the Route 54 / 322 projects in regards to the completion of the continuing roadway improvements. The final paving work along Route 322 has been delayed due to the rain the past week but is scheduled to begin within the next week. The work will be completed overnight from 9pm to 5am and take approximately 2 - 3 days. All work along Route 322 is expected to be completed by Memorial Day.

MAYOR'S REPORT: Mayor Destefano wished everyone a happy and safe Memorial Day weekend. Mayor DeStefano also wished Jonathan Maturano congratulations on being a semi- finalist in the Louis Bay 2nd Scholarship Essay Contest.

COUNCIL MEMBER'S REPORTS:

Councilwoman Veneziani: no report this evening. Councilwoman Veneziani wished everyone a happy and safe Memorial Day weekend.

Councilman Kyle Smith: asked everyone to use more caution when driving this time of year as the weather gets nicer. He encouraged residents to go see a softball and baseball game and visit the concession stand. Councilman Smith asked residents to remember all the people who have died while serving in the armed forces this Memorial Day weekend.

Councilman Ken Jantz: stated that he and Council President Pagano did an evaluation of the street lights this past month and found five (5) that were out and notified the electric company. Councilman Jantz reported to Engineer Gary Auer that the street light on the new overpass is out. Councilman Jantz reminded residents that you can go to the Borough website and report any street lights that are out.

Councilman President Ben Pagano: reported that the tax maps have been updated and we can now more on to the reval. Council President Pagano also reported that on May 27 there will be a ceremony at the Atlantic County Veterans' Cemetery. Ben alluded to what Councilman Smith stated about the armed forces and thanked God and blessed all their souls and their families

Councilman Charlie Arena: read the Public Works report

Reminded residents that the Public Works Department picked up liter several times on 14th Street. The crews do this once a month . Councilman Arena reminded residents that they maybe times the residents may have to do their own housecleaning until the crews can get there. Councilman Arena thanked Folsom School for donating the rubber mulch to the Falcon's Nest playground.

- (1) Safety inspection of emergency lighting / fire extinguishers Borough hall and public works buildings. Safety inspection of 4 parks and all ball fields monthly and after every storm.
- (2) The Public works dept. attends the Atlantic County Joint Insurance Safety Kick off meeting as part of the towns requirements.
- (3) Cut the grass at Borough Hall and all Ball fields as part of our weekly routine (4) times a month.
- (4) picked up litter on 14th St. from the Hammonton line to Rt. 322 (on 4/15/2016)
- (5) Removed the Folsom vol. co. sign from Building Per council men Smith.
- (6) Installed ADA paths in Penny Pot Park. (Used millings) for the application approval.
- (7) Meet with Polistina and associates with Ron Esposito to discuss the path and the ACIA GRANT funding. For exercise equipment at the parks also. Location both path and equipment.
- (8) Picked litter up on 8th St. on (4-21 and 4-22-2016)
- (9) Started filling some of the larger cracks at borough hall had to stop due to weather
- (10) Repaired Fence on back stop and dug-outs on the T-Ball field for safety.
- (11) Repaired post caps on the Falcons nest tot lot and replaced (S) hooks on swing set at tot lot
- (12) Due to Vandalism the Public works dept. installed pad locks on electrical panels in the 13th St. Park inside the locked fenced area.
- (13) Due to Vandalism bolted bleachers down at girl's soft ball field to prevent from being moved into walking path and grass area.
- (14) Removed 4 large trees from Falcons nest Park dead pines and one black walnut.
- (15) On 3 separate occasions we dragged and lined girl's soft ball field for school and all other fields for safety.
- (16) For our monthly yard waste program we chipped 80 cubic yards of brush throughout the town.
- (17) For our spring leaf collection program this month we collected 100 cubic yards.

Mayor DeStefano reminded residents that leaf pick-up ends on May 20, 2016.

Councilman Byron Gummoe: wanted to clear the air over his leaving the Council meeting last month. Councilman Gummoed state that when Council President was speaking Councilwoman Veneziani interrupted the Council President and I suddenly became aware that I had been given conflicting information. Rather than embarrass the individuals concerned by questioning and divulging this information I chose to leave the meeting to protect the concerned individuals. My leaving was in no way reflective of Council President Pagano or his report. Councilman Gummoe stated that the Ordinance Review Committee is still trying to get the Cat Ordinance completed and hopefully it will be done by next month.
